- 2. WHEREAS National Instrument 55-102 *System for Electronic Disclosure by Insiders* (SEDI)("NI 55-102") sets out the filing requirements for the electronic filing of insider reports and related issuer information in SEDI;
- 3. AND WHEREAS NI 55-102 becomes effective on October 29, 2001, except for sections 2.1, 2.2 and 2.4 which become effective on November 13, 2001;
- 3. AND WHEREAS the Canadian Securities Administrators have decided to extend the filing and reporting deadlines under NI 55-102;
- 4. AND WHEREAS the Commission is satisfied that to do so would not be prejudicial to the public interest;
- 5. IT IS HEREBY ORDERED pursuant to section 185 of the Act that:
  - 5.1 SEDI issuers are exempt from the requirement under section 7.1 of NI 55-102 to file an issuer profile supplement in SEDI format until November 19, 2001;
  - 5.2 Insiders of SEDI issuers are exempt from the requirement in section 7.2 of NI 55-102 to file their insider reports, including an amended insider report, in SEDI

format, in respect of a relationship to, or a transaction in securities of, the SED
issuer which arose prior to that date, until December 17, 2001;

5.3 SEDI issuers and insiders of SEDI issuers are exempt from the requirements of sections 2.1, 2.2 and 2.4 of NI 55-102 until December 17, 2001.
